



Rules and Regulations

Governing Body — This show shall be run in accordance with USEF rules, except where GOHJA rules dictate otherwise.

Headgear — Protective A.S.T.M./S.E.I approved Headgear is mandatory at all times when mounted. Chin straps must be snug.

Judging — Classes will be judged on performance and soundness unless otherwise noted.

Attire — Proper attire required in all classes. Jackets my be waived at the discretion of Show Management based on weather conditions.

Schooling — All schooling will be confined to designated areas. Schooling in the show rings will be limited to specific times. See class schedule for times.

Classes — Show Management reserves the right to combine or cancel any class(es) with the appropriate notification.

The 3-Minute Rule — This will be used as required to prevent unnecessary show delays and will be strictly enforced. No ring will "hold" for more than 30 min. for a conflict.

Time Management – Trainer conflicts will not be allowed for flat classes.

Entries — All entries must be listed on an entry form. The Secretary will not issue a number until the entry

form is signed. All horses and riders entering the show rings or the schooling rings must be entered, including those not showing. All horses and riders, on the show grounds must be registered with the Secretary.

Rules and Regulations Continued

Rider Changes — Rider changes must be recorded with the Secretary's office.

Class Questions — Complete class specifications are available in the GOHJA Rule Book. If one is not available to you, contact the Steward prior to the start of the show if you have any questions.

Jogs – Soundness will be considered, but entries will not jog.

Flat Classes – No martingales permitted in any flat class.

Prizes — Ribbons will be awarded for first through sixth place in all classes. All entrants in Leadline and Walk-Trot will receive ribbons.

Year End — Points toward year-end awards will only be awarded to GOHJA members and/or GOHJA recorded horses/ponies.

Champion/Reserve — Points toward show-day Division Champion and division Reserve Champion will be awarded to the top six placings in each class, except Training Hunter and Leadline for all divisions.

Training Hunter — Entries for Training Hunter must pre-enter or complete an Add/Scratch Form at the Secretary's office and give to in-gate person before entering show ring.

Back Numbers — A current show # must be worn to enter warm-up or show ring.





CLASS DESCRIPTIONS

All hunter divisions have two jump classes and an under saddle class. Horses will walk, trot, and canter both ways of the ring. Under saddle classes allow not more than 8 to hand gallop at one time. No hand gallop in the following hunter divisions: Modified Children's, Modified Adult, Children's, Schooling, Low and Green. No martingales in any hunter flat classes. *All classes are USHJA Outreach eligible except for the leadline and walk class. If you are a current member of the USHJA Outreach program your points will automatically be counted. If you would like to become an Outreach member please visit https://www.ushja.org/competition/outreach to sign up.

WALK-TROT: Equitation, Pleasure, and Hunter Hack. Open to riders in the appropriate age group who have not cantered at a GOHJA show. Walk and trot both ways of the ring. The Hunter Hack is judged as an u/s class. After hacking all will trot two poles. May not cross enter Walktrot and Cross Rails.

SHORT-STIRRUP HUNTER: Open to riders 12 & under, who have not jumped over 18" at a GOHJA or USEF show. Fences not to exceed 18". Walk, trot, and canter, both ways of the ring.

LONG-STIRRUP HUNTER: Open to amateur riders 13 & over. Other specifications same as Short Stirrup. Riders wishing to reinstate eligibility for this division should contact the Hearings Committee.

LOW HUNTER: Open to horses and ponies. Fences 2'6" or 2'3" (No in & out)

SCHOOLING HUNTER: Open to horses and ponies. Fences 2'9" or 3'3".

GREEN HUNTER: 1st year horses fences 2'9", 2nd year horses fences 3' judged as one division, U/S combined.

OPEN HUNTER: Fences 3' or 2'9" maximum.

CHILDREN'S PONY HUNTER: Open to Junior riders only on ponies. May cross enter where eligible. Small/medium/large ponies designate fence height 2' or 2'6". No in and out and lines will not be adjusted.

LOW CHILDREN'S HUNTER: Open to Junior riders on horses; 2'6" fence height. Horse/Rider combination may not cross enter into High Children's or Modified at the same show.

HIGH CHILDREN'S HUNTER: Open to Junior riders on horses; 3'0" or 2'9" fence height. Horse/Rider combination may not cross enter into Low Children's or Modified at the same show.

LOW ADULT HUNTER: Open to Amateur riders on horses or ponies; 2'6" fence height. Horse/Rider combination may not cross enter into High Adult or Modified at the same show.

HIGH ADULT HUNTER: Open to Amateur riders on horses or ponies; 2'9" or 3'0" fence height. Horse/Rider combination may not cross enter into Low Adult or Modified at the same show.

MODIFIED HUNTER: Open to Junior or Amateur riders on horses or ponies; 2'3" fence height. Horse/Rider combination may not cross enter into High Children's, Low Children's, High Adult, or Low Adult at the same show.

CROSS RAIL HUNTER: Open to all riders on horses or ponies; 15" fence height. May trot or canter. Horse/Rider combination may not cross enter into any class where fence heights exceed 2'0". Note that riders may cross enter into Short or Long Stirrups if eligible, but Walk Trot riders lose their W/T eligibility by entering these jump classes.

BEGINNER RIDER HUNTER: Open to Junior and Amateur riders. Not to have jumped over 2'3" in any GOHJA or USEF show. May cross enter into GOHJA over fences that are 2' and 2'3" in fence height. Fence height 2'. Entrants may ride more than one horse. Rider complete for 2 years.

BABY GREEN HUNTER: Open to horses and ponies in their first and second year of showing 2' fence height. Can cross enter 2'3" divisions.

CLASS DESCRIPTIONS

CROSS RAIL WALK-TROT HUNTER: Same as Cross Rail Hunter, except no canter.

TRAINING HUNTER: To be offered immediately before each division at the fence height for that division. May only be ridden once per horse/pony per ring. To be numerically scored by the judge as a hunter over fences round. Entries scoring between 70 and 75 receive a red ribbon and entries scoring greater than 75 receive a blue ribbon. Does not count toward any year-end or hi-point awards.

 ${\bf MEDAL}:$ Open to Amateur/junior GOHJA members. Fences 2'9" or 3', USEF test 1-18. Top 4 must test additionally.

Mini MEDAL: Open to Junior/Amateur GOHJA members. Fences 2'9" or 3', USEF tests 1-8. Top 4 must test additionally.

PONY MEDAL: Open to Junior members on ponies only. No in & out. USEF age restrictions apply. Rider may not cross enter into any other Medal at the same show. Pony must have USEF or GOHJA measurement card. Original course to contain at least two tests–USEF tests 1-8–no additional testing. Fence heights 2'0" or 2'6".

OPEN EQUITATION MEDAL: 2'3" & 2: riders may not cross enter into any other GOHJA medals at same show.

PONY EQUITATION: Fences 2'/2'6": no in and out. Junior Equitation 2'6"/2'9"/3'. Adult: fences 2'6"/2'9"/3', amateur to ride

OPEN EQUITATION: Open to Junior and Amateur riders any age. Choice of fence height 2' or 2'3", no on & out. Rider may not cross enter into any other age group equitation class.

CROSS RAIL EQUITATION: Open to Junior or Amateur riders on horses or ponies 15" fence height.

CROSS RAIL WALK-TROT EQUITATION: Same as above except no canter. May only cross enter into Walk-Trot. Canter to be penalized.

BEGINNER RIDER EQUITATION: Open to Junior and Amateurs of any age. May cross enter into any other GOHJA over fences that are 2' or 2'3". Rider may not have jumped over 2'3" at GOHJA or USEF shows. Fences 2'.

PUDDLE JUMPER: Open to Junior and Senior riders. Designed to be a beginner jumper division. Fences 2' with a spread maximum of 2'.


PUDDLE JUMPER: Open to Junior and Senior riders. Designed to be a beginner jumper division. Fences 2'3" with a spread maximum of 2'3".

OPEN JUMPER: LEVEL 0: Fences 2'6" or 2'9", spreads not to exceed 2'6". **LEVEL 1:** Fences 3' or 3'3", spreads 3' to 3'3".

CHILDREN/ADULT AMATEUR JUMPER: Fences 3', spreads not to exceed 3'.

TIP Hunter:

Must have TIP# from the Jockey Club Fence height to be choice of 2'3",2'6",2'9" Two classes over fences with a minimum of 7 jumps. Under saddle-w,t,c- no hand gallop, no martingale.

Membership applications will not be accepted without appropriate payment. Make checks payable to "GOHJA".

Membership applications will not be accepted without appropriate signatures. Parent or Legal Guardian must sign for minor members. Trainers or Barn Managers are not authorized signers.

An individual will automatically become a member of GOHJA and dues will be assessed Memberships go into effect when application is complete per above and received by the Show Secretary at a GOHJA show or received (postmarked) through the US mail by the Membership Secretary. Exhibitors at GOHJA sanctioned competitions must be members in order to accumulate points toward Year-End awards.

Membership is not retroactive; exhibitors must be members on or before the date of a competition to receive points from that show.

Membership Types:

Junior: A single membership for an individual who is 17 years old or younger on December 1, 2024.

Senior: A single membership for an individual who is 18 years old or older on December 1, 2024 and meets the criteria of USEF GR1306 for Amateur Status. May be an Amateur, Professional or Supporting member.

Professional: A single membership for an individual who is 18 years old or older on December 1, 2024 and meets the criteria of USEF GR1308 for Professional Status.

Family: A membership for a husband, wife, partner and all children or step-children (under age 18) living in the same household.

Organization: A membership for an Organization (group, business, etc.) which includes membership for one Senior individual.

Lifetime: A membership for a single individual which does not expire for the life of the individual.
